TREASURER REPORT: Janet reported a balance in our account of \$215.875.54, with about \$32,000 in the roof reserve,

OLD BUSINESS: The Application fee was to to raised to \$100.00 with an additional \$50.00 for each additional resident. This includes the background checks. Motion was made by Janet to increase the fees as stated, motion seconded by Mary C. Motion carried. The repairs to G-2 found during an inspection have been completed. J1 grass, apprears very brown and like it's dying. We have been in contact with JJ. They said to have it fertilized. Which we had done. Then JJ said to

see how it is in the spring. The sprinklers have been checked. So far nothing has changed, in fact it seems to be spreading. Mary M. and Tom have given us several suggestions for JJ to try to get this under control. Janet will contact JJ. One important thing that Mary M. learned during her research was that it is important to keep mulch 1 to 1&1/2 feet from the house as it can draw termintes.

NEW BUSINESS: E1, front bushes that replaced the bushes that had to be removed last year when the plumbing repairs were done.

Mary M. and Tom are working on this project.

B1, some of the bushes have been removed by the owner. The bushes have grown under the siding, even causing some peices of siding to crack. The bushes near the road need to be

trimmed due to no line of sight to exit the driveway, causing a saftey issue.

The Board will review the contract with JJ Landscaping and verify what they are doing and what services we should be getting. We will be looking for a new landscaper.

I3. Fascia is in need or repair and paint. Dena and Mary C. will be check all of the units for these problems to see how many units are involved, then get estimates for the needed repairs.
